Judge Jonathan Braden gave Kyle Heuerman his Oath of Office.

Discuss Solar Farm-Representative from Grant Thornton, InDeck and the City of Marshall were in attendance to answer questions. InDeck would like to install a solar farm, they have purchased 1467 acres with the majority in Clark County. 72 acres is in Cumberland County. This is a privately held corporation. They are asking Cumberland County to join the Clark County Enterprise Zone. They would like to start construction in the spring of 2021 and be up and running by June of 2022. They will be bonded for cleanup if they go out of business. This will create 5-10 jobs. The construction will create 200-300 jobs. The Board will hold a special meeting to discuss passing a resolution to support the enterprise zone.

Tim Jackson, Lincoln Trail Motosport Recreation Park and Track- Mr. Jackson is asking the County to abate his taxes. He has been in business for 11 years and made many improvements to the property. He had a fire and built a new building last year. He will be taking over the township road going to his property. He will widen and maintain. There are around 46 thousand to 50 thousand people that visit each year. He has 15-20 events and 12-15 practice events. He is open 7 days a week. Local businesses see the increase in traffic. They have their own EMT staff from Wisconsin who hires local help. He employees 25 – 30 high school kids.

Discuss and take action on abatement of taxes for Lincoln Trail Motosport Recreation Park and Track

Beard stated that if we do the abatement, we would also be helping other businesses. Heuerman stated that we need a policy so that businesses are treated the same. Jenny Maynard stated that the abatement would amount to a little over \$1,000.00 for the County's portion.
