**DISCUSS PRECINCT SIZE-Senate Bill 536 was signed into law on November 15, 2021; with in this bill the County Board shall as near as may be practicable increase precinct sizes to 1200 registered voters. Greenup Twp would be the only one that could be changed; reduce to 2 precincts from 3. We would need to hire a company such as Sidwell to create the new boundaries. It would need to be done by January 14, 2022. If not done the board will look at the sizes after the next November election and will have until the following June. No action will be taken at this time.**
