Holkenbrink feels that the current plan will clutter the court yard. Do we need the 911 steel and the park monuments added? He thinks landscaping around the concrete may be too much maintenance. Beard stated that the lights could be put in the concrete and rock landscaping would not be needed. Kaye thinks it should be at the Legion and Tania Craig stated that there is no room. Carrie Verdeyen was given permission from the County Board to put Memorial on the Court yard because it is for everyone in the County. Beard would like to stick with the original agreement. Beard asked about the survivor tree and it is an American elm. Layton stated that we need to keep the 911 display to draw tourist and the park monument needs to be moved. Blade agrees that the 911 display should be kept. Robert Sponsel asked the board if they approved the memorial each time they have asked why is it a problem now. Heuerman stated that it is like house plans; you need to try and visualize and do it in stages. Layton told Carrie that she is still fulfilling her promise. Carrie would like to discuss the landscaping when it is time for it. Billie Chambers said that rocks in landscaping could be a problem when mowing and mentioned lights that stand up. The park monument will be cleaned, the letter and stars will be re-whitened. Anyone from Cumberland County that has served or is serving can be on the monument.
