Robbins stated that an ordinance would help if an owner abandons property and lets people move in with tents. Heuerman is OK with having rules for public property but not private property. Robbins stated the County is only liable if negligent. Layton thinks we should just drop the matter.



**DISCUSS SIDE X SIDE PERMITS:** Roads would need posted speed limit signs of 35 mph. The Sheriff has no issues or reports of issues at this time. There have been few accidents. Owners should have insurance if they ride on roads. Holkenbrink is in favor of not doing anything.


