Audience member, Dale Decker, was against the increase 4 years ago. He took petitions around objecting. He thinks raising area 3 is unfair.


Jonathan Kaye left the hearing at 6:21 pm


Beard wants to dissolve the SSA and force it on the Toledo Fire District
