**DISCUSS AND TAKE ACTION ON SPECIAL SERVICE AREA LEVIES-Layton stated that he dislikes taxes unless they are used to help save lives. Heuerman says that they will still fail with the increase. This is not a solution. Kaye stated that an organization in Crawford County has taken over Jasper County and Clark County is in talks with them. We should all align together. The current Ambulance has not received any grants so the burden is all on the taxpayer. Heuerman stated that we should look at the County as a whole service area since Springpoint Twp does not pay an ambulance tax. He has been in contact with State Reps. Beard stated why mess with what's working. Kaye stated that a Fire dept with an ambulance has more grant opportunities. Holkenbrink stated that the Special Service Area Commission requested the levy increase. There was a Truth in Taxation hearing conducted.**


