DISCUSS AND TAKE ACTION ON HOLDING TRUTH IN TAXATION HEARING FOR SPECIAL SERVICE AREAS

Mike Black, SSA Commission, gave an overview of the Commission and the Toledo Ambulance Service. \$133,129.00 was extended from the SSA tax levies; approx. \$.22 per \$100.00 of assessed evaluation. The commission is asking for a total tax levy of \$206,654; which is approx. \$.32 per \$100.00 of assessed evaluation This is a total increase of \$73,525.00; which is over 5% in each area.

A Motion was made by <u>Layton</u> and seconded by <u>Brandenburg</u> to hold a Truth in Taxation Hearing for Special Service Areas 1, 2, & 3 on December 13, 2024 at 6:00 pm at the Cumberland County Courthouse to approve a levy increase for each area to collect \$206,654.00; approx. \$.32 per \$100.00 of EAV.
