NOTICE OF PUBLIC HEARING

Notice is given that a public hearing by the Cumberland County Board will be held on Wednesday, January 7, 2026, at 6:00 PM in the upstairs courtroom of the Cumberland County Courthouse, 1 Courthouse Square, Toledo, Illinois 62468. The public hearing will be held in accordance with 55 ILCS 5/5-12020, in order to determine whether a commercial solar energy facility and battery energy storage system ("BESS") proposed by Cumberland Road North Solar Project, LLC, has met all requirements of the Cumberland County Solar Energy System (SES) Ordinance 25-07 and the Cumberland County Battery Energy Storage Systems (BESS) Ordinance 25-09. Cumberland Road North Solar Project, LLC, is a wholly owned subsidiary of Savion, LLC. Cumberland Road North Solar Project, LLC, and Savion, LLC, both have the contact address of 422 Admiral Boulevard, Kansas City, MO 64106.
