 here to answer any questions on the closure of Rt 121 and the detour being the Burma. Usually when there is a closure, they try to re-route on a state road but it is not possible this time. Layton was concerned on the traffic that would probably use 1200N or the county line road. The state could offer to monitor 1200N. Authorities could also put up signs closing to thru traffic. Hopefully this project will only take a few months. Knueppel asked the States Attorney if he could ask a question about the covered bridge and was told yes. He wanted to know who maintains the covered bridge and Mr. Jamerson said it would be the state's responsibility. Tim McMechan wanted to know when the I-70 bridge over the Midget would be fixed. Mr. Jamerson did not know at this time.



**SARA RUHOLL, BROADBAND COMMITTEE-**This resolution is to get Nextlink to give a timeline of work. The broadband committee worked 16 weeks then found out the County was not eligible for the grant because Nextlink had been awarded a grant in 2018. They have 10 years (2028) in the original contract. Crawford County is having the same issue.


